Moreover, I would like to communicate you that I was shortlisted for the interview for the post of block programme manager as per your office advertisement notice No. MD/JKSRM/06/2014-1 Dated 29/06/2016 and I was appeared in the interview and interviewed by Dr. G. N gasba who was mission director. JKSRM st that time for the above said post which was mentioned in the advertisement notice no. MD/JKSRM/062014-1 dated 29-062016. In this regard kindly inform me, as that time why I was eligible and shortlisted for the interview for the post of block programme manager as per your office advertisement notice no. MD/JKSRM/06/2014-1 dated 29/06/2016 and now, I am ineligible for the post of state project manager (Livelihoods) advertised vide notification No. MD/JKSRM/2014-part-iv/2018 dated 28-03-2018. as such my advertisement notice is not available for this post.</p>

I don't understand why only 58 years of experience is considered relevant now, when another notification of yours - Advertisement Notice No. MD/JKSRM/06/2014-Part-I dated 28.04.2017, shortlisted me eligible with 80 months' relevant experience for the position of District Program Manager (which is attached in the email).</p> <p>2. It seems this time you have taken my teaching and research experience in social work and rural development out as not relevant experience. However, the former State Project Manager (Livelihood), who resigned and led to the creation of this position, had most of this experience in teaching of social work. So why can't my experience in teaching be counted as relevant experience. So in the view of above two points, I request you to please re-look into my application and see the possibilities of considering it eligible to interview.</p>

Observations of JKSRM

On Examination of your application form it has been found that you have qualified MARD In 2015. Hence not having sufficient post qualification experience. Therefore not eligible for the post.

On Examination of your application form it has been found that you have qualified MARD In 2016. Hence not having sufficient post qualification experience. Therefore not eligible for the post.

On Examining your application form it was found that you don't possess the required qualification of Masters Degree in Rural Development or Social Work. Hence you are not eligible for the post.

On Examination of your application form it has been found that the experience mentioned is not as per the requirement of the Mission. Only the relevant post qualification experience mentioned in the application form has been considered which is not sufficient for the post.
