Whereas, the advertisement Notice for filling up of contractual posts of District Programme Manager and Block Programme Manager was advertised vide Notification No. MD/JKSRLM/06/2014-Part-I dated 28-04-2017.

Whereas, in response to the said notification, applications were received and accordingly scrutinized by the committee constituted by this office. The list of eligible and ineligible candidates was notified vide no. MD/JKSRLM/06/2014-Part-1 dated 23-02-2018 for inviting objections to the said scrutiny, if any.

Whereas, objections were received and disposed off on merits of each case, accordingly the syllabus for the written test, final list of eligible candidates with reply to each objections from JKSRLM was notified vide no. MD/JKSRLM/06/2014-Part-III/420 dated 22-06-2018.

Whereas, it was notified through print media that the eligible candidates can obtain their Admit cards from Additional Mission Director Jammu/Kashmir from 27th of December 2018 to 3rd of January 2018.

Whereas, one candidate namely Shazia Majid telephonically informed that her admit card is not available in the office of Additional Mission Director JKSRLM Kashmir.

Whereas, cursory check of the case warranted proper examination through the screening committee constituted for scrutiny of application forms.

Whereas, the screening committee already constituted were advised to examine the case of Shazia Majid. The committee after examination has reported that the candidate is not figuring in the list of eligible candidates as notified earlier, however then screening Committee in response to the objections submitted by the candidates has made clear that she is eligible for the post of BPM.

Whereas, the committee further reported that during examination one more candidate namely Mahsood Ahmad Wani has been found in a similarly situated case and recommended that both the candidates be included in the final list of BPM's.

Now therefore, it is notified for information of all, that the candidates namely Shazia Majid and Mashood Ahmad Wani are included in the final list of eligible candidates for the post of Block Programme Manger (BPM). The candidates are advised through the

medium of this notice to collect their admit cards for the post of Block Programme Manager from office of Additional Mission Director, JKSRLM, Kashmir.
