Whereas, vide notification dated 04th of December, 2018 issued under endorsement no. MD/JKSRLM/06/2014-Part-IV/620 dated 04-12-2018 the criteria of selection for the above mentioned posts was notified through print media and also uploaded on the official website of this office;

Whereas, as per the said notification the criteria of selection notified for the above mentioned posts was two tier selection viz written test 80 points followed by interview 20 points;

Whereas, the Administrative Department vide letter no. RDD/P&S/493/2018 dated 01-01-2019 advised to conclude the exercise for engagement of Human Resource on the basis of written examination only and no interviews be conducted;

Whereas, the mission vide letter no. MD/JKSRLM/06/2014-Part-IV/24 dated 07-01-2019 sought some clarifications with regard to the already notified selection criteria;

Whereas, the Administrative Department vide letter no. RDD/P&S/493/2018 dated 22-01-2019 again advised to do away with the interview and make selection on the basis of written tests only;

Now therefore, it is notified for information of all the candidates who appeared in the written examination for the above mentioned posts that the selection criteria already issued vide notification dated 04th of December, 2018 issued under endorsement no. MD/JKSRLM/06/2014-Part-IV/620 dated 04-12-2018 is hereby withdrawn. The selection for the above posts shall now be made on the basis of written examination only and there will be no interview. However the selection for the post of District Programme Manager shall be subject to the outcome of SWP No. 3025/2018 titled Raja Suhail and others V/s state of J&K and others.
